Electronic Filing Pilot Program

On February 10, 1999 the International Bureau will begin a pilot program for electronic filing of applications through the IBFS system. The two-month pilot program is intended to begin the process of a transition to full electronic filing of applications received by the Bureau, and to gather suggestions for modification and enhancement of services provided through IBFS.

The IBFS system currently allows for the electronic filing of the following types of applications:

International Section 214 Special Temporary Authority (Part 63)	Space Station Authorizations - Form 312

This report lists Section 214 applications that have been filed with the Bureau, entered into the IBFS system, but not released on an Accepted for Filing Public Notice.
2. Accounting Rate Current Authorization Listing by Carrier
List all processed international accounting rate change filings (ARC) sorted alphabetically by carrier.
3. Accounting Rate Current Authorization Listing by Administration
List all processed international accounting rate change (ARC) filings sorted alphabetically by administration.
4. Accounting Rate Pending Listing by Carrier
List all pending international accounting rate change (ARC) filings sorted alphabetically by carrier.
5. Accounting Rate Pending Listing by Administration
List all pending international accounting rate change (ARC) filings sorted alphabetically by administration.
6. Data Network Identification Code Pending Application List
Lists all pending requests for data network identification codes (DNC).
7. Foreign Carrier Affiliation Notification Pending Application List
Lists all pending foreign carrier affiliation notification (FCN) filings.
8. International Special Projects Pending Applications
Lists all pending international special project (ISP) applications. ISP is a application type determined by the Commission.
9. International Telecommunications Pending Application List
Lists all pending Section 214 (ITC) applications.
10. Recognized Operating Agency Pending Application List
Lists all pending recognized operating agency requests.
11. Submarine Cable Landing Pending Application List
Lists all pending submarine cable landing license (SCL) applications.
12. SPC Assignment Listing for a Given State
Allows users to select a state and retrieve a list of all international signalling point code (SPC) assignments for that state.
13. ISPC Assignment Listing
Lists all international signalling point code (SPC) assignments.
14. ISPC Pending Application List

Lists all pending international signalling point code (SPC) applications.

Satellite Earth Station Reports

1. Pending Application List
Lists all pending Earth station applications.
2. Application Search Tool
Allows users to retrieve lists of applications (pending and completed) for a given state (site of the facility), application type and/or nature of service.
3. Current Authorization List by Licensee
Lists all current Earth station authorizations sorted in licensee order.
4. Current Authorization List by Callsign
Lists all current Earth station authorizations sorted in call sign order.
5. Current Authorization List by State and City
Lists all current Earth station authorizations sorted by the state and city of the site of the facility.
6. List of File Numbers for a Given Call Sign
This report allows users to enter a call sign and retrieve a list of all file numbers associated with that call sign.
7. VSAT Authorization List
Lists all current VSAT authorizations.
8. Selected Application by File Number
This report allows users to retrieve information on a specific application by entering its file number.

Satellite Space Station Reports

1. Pending Application List
Lists all pending space station applications.
2. Current Authorization by File Number
Lists all current space station authorizations sorted by file number.
3. Current Authorization by Callsign
Lists all current space station authorizations sorted by callsign.
4. Current Authorization by Licensee
Lists all current space station authorizations sorted by licensee.

International HF Broadcast and International

1. 325-C Pending Application List
Lists all pending Section 325-C (Permit to deliver programs to foreign broadcast stations) applications.
2. IHF Pending Application List
Lists all pending International High Frequency Broadcast (IHF) applications.
3. IHF Current Authorizations by File Number
Lists all current International High Frequency Broadcast (IHF) authorizations sorted in file number order.
4. IHF Current Authorizations by Expiration Due Date
Lists all current International High Frequency Broadcast (IHF) authorizations sorted in expiration due date order.
5. IPF Pending Application List
Lists all pending International Public Fixed Radio (IPF) applications.
6. IPF Current Authorizations by File Number
Lists all current International Public Fixed Radio (IPF) authorizations sorted in file number order.
7. IPF Current Authorizations by Callsign
Lists all current International Public Fixed Radio (IPF) authorizations sorted in callsign order.

Other Reports

1. Selected Application Status
This report allows users to enter a file number and returns that application's processing status.
2. Condition and Provision Text Listing for a Given Condition Code
Users may enter a specific condition code from a license or authorization and retrieve the full text of the condition.
3. Condition and Provision Text Listing for a Given Subsystem
Users select a subsystem (i.e., ITC, SES, SAT, etc.) and retrieve the full list of conditions and provisions associated with that subsystem.
4. Condition and Provision Text Listing by Code Number
This report lists all conditions and provisions assigned to licenses or authorizations sorted by their code numbers.
