THE AUTHORITY GRANTED WITH THE FOLLOWING CONDITIONS:

Antenna and ground system: Vertical, guyed, series-excited, steel radiator of uniform cross-section 60.96 m (106.15°) in height (62.18° overall). Theoretical efficiency is 315.43 mV/m/Kw at 1 KM. Ground system consists of 180 equally spaced, buried, copper radials 70.0 m in length plus 100 interspaced radials 15.24m in length and a 7.62m by 7.62m copper ground screen.

Conditions: Licensee shall accept such interference as may be imposed by other existing 250 watts Class IV stations in the event they are subsequently authorized to increase power to 1000 watts.
