5 (b) Subpart A of such part is amended by striking out  
6 the heading of such subpart and inserting in lieu thereof  
7 "ASSISTANCE FOR NONCOMMERCIAL EDUCATIONAL BROAD-  
8 CASTING FACILITIES AND TELECOMMUNICATIONS DEMON-  
9 STRATIONS".

10 (c) Section 390 of such Act is amended to read as  
11 follows:

12 "DECLARATION OF PURPOSE

13 "SEC. 390. The purposes of this subpart are (1) to  
14 assist (through matching grants) in the construction of non-  
15 commercial educational television or radio broadcasting  
16 facilities, and (2) to demonstrate (through grants or con-  
17 tracts) the use of telecommunications technologies for the  
18 distribution and dissemination of health, education, and other  
19 public or social service information."

20 AUTHORIZATION OF APPROPRIATIONS

21 SEC. 3. Section 391 of the Communications Act of 1934  
22 is amended to read as follows:

23 "SEC. 391. There are authorized to be appropriated  
24 \$7,500,000 for the period July 1, 1976, through Septem-  
25 ber 30, 1976, and \$30,000,000 for the fiscal year ending

1 September 30, 1977, to assist (through matching grants) in  
2 the construction of noncommercial educational television or  
3 radio broadcasting facilities as provided in this subpart.  
4 Sums appropriated under this section for any fiscal year or  
5 period shall remain available for payment of grants for  
6 projects for which applications approved under section 392  
7 have been submitted under such section within one year after  
8 the last day of such fiscal year or period.”.

9 CRITERIA FOR BROADCAST FACILITIES CONSTRUCTION

10 SEC. 4. (a) Section 392 (a) (1) of the Communications  
11 Act of 1934 is amended by striking out clause (C) and  
12 inserting in lieu thereof “(C) a public or private nonprofit  
13 college or university *or other educational or cultural institu-*  
14 *tion which is affiliated with an eligible college or university,*”.

15 (b) Section 392 (d) of such Act is amended to read  
16 as follows:

17 “(d) (1) The Secretary shall base his determinations  
18 of whether to approve applications for television grants  
19 under this section and the amount of such grants on criteria  
20 set forth in regulations and designed to achieve (A) a  
21 strengthening of the capability of existing noncommercial  
22 educational television stations to provide local services; (B)  
23 the adaptation of existing noncommercial educational tele-  
24 vision facilities to broaden educational uses; and (C) ex-  
25 tension of noncommercial educational television services,

1 with due consideration to equitable geographic coverage  
2 throughout the United States.

3 “(2) The Secretary shall base his determination of  
4 whether to approve applications for radio grants under this  
5 section and the amount of such grants on criteria set forth in  
6 regulations and designed to achieve (A) extension of non-  
7 commercial educational radio services with due consideration  
8 to equitable geographic coverage throughout the United  
9 States; (B) a strengthening of the capability of existing  
10 noncommercial educational radio stations to provide local  
11 service; and (C) the provision of multiple radio stations in  
12 major population centers to broaden services for special  
13 interest, minority, and educational uses.”.

14 **COORDINATION**

15 **SEC. 5.** Section 395 of the Communications Act of 1934  
16 is amended to read as follows:

17 “**COORDINATION WITH THE COMMISSION AND THE**  
18 **CORPORATION**

19 “**SEC. 395.** The Federal Communications Commission  
20 is authorized to provide such assistance in carrying out the  
21 provisions of this subpart as may be requested by the Secre-  
22 tary. The Secretary shall provide for close coordination with  
23 the Federal Communications Commission in the administra-  
24 tion of his functions under this subpart which are of interest  
25 to or affect the functions of the Commission. The Secretary  
26 shall provide for close coordination with the Corporation

1 for Public Broadcasting in the administration of his functions  
2 under this subpart which are of interest to or affect the func-  
3 tions of the Corporation.”.

#### 4 CONSTRUCTION

5 SEC. 6. Section 397 (2) of the Communications Act of  
6 1934 is amended to read as follows:

7 “(2) The term ‘construction’, as applied to educational  
8 television broadcasting facilities or educational radio broad-  
9 casting facilities, means the acquisition and installation of  
10 transmission and reception apparatus (including towers,  
11 microwave equipment, boosters, translators, repeaters,  
12 mobile equipment, video recording equipment, nonvideo  
13 recording equipment, radio subcarrier receivers, and satellite  
14 transceivers) necessary for television broadcasting or radio  
15 broadcasting, as the case may be, including apparatus which  
16 may incidentally be used for transmitting closed circuit  
17 television or radio programs, but such term does not include  
18 the construction or repair of structures to house such appara-  
19 tus. In the case of apparatus, the acquisition and installation  
20 of which is so included, such term also includes planning  
21 therefor.”.

#### 22 AUDIO RECORDING EQUIPMENT

23 SEC. 7. Section 399 (b) of the Communications Act of  
24 1934 is amended by adding at the end thereof the following  
25 new paragraph:

1       “(5) From amounts appropriated pursuant to section  
 2 391 after the date of enactment of this paragraph, the Sec-  
 3 retary may make a grant to any licensee of a noncommer-  
 4 cial educational broadcast station who received assistance  
 5 under this part of the full amount necessary to acquire equip-  
 6 ment to permit such licensee to comply with paragraph (1)  
 7 of this subsection.”.

8                               TELECOMMUNICATIONS DEMONSTRATIONS

9       SEC. 8. The Communications Act of 1934 is amended  
 10 by adding after section 392 the following new section:

11                               “TELECOMMUNICATIONS DEMONSTRATIONS

12       “SEC. 392A. (a) It is the purpose of this section to pro-  
 13 mote the development of nonbroadcast telecommunications  
 14 facilities and services for the transmission, distribution and  
 15 delivery of health, education, and public or social service  
 16 information. The Secretary is authorized, upon receipt of an  
 17 application in such form and containing such information as  
 18 he may by regulation require, to make grants to, and enter  
 19 into contracts with public and private nonprofit agencies,  
 20 organizations, and institutions for the purpose of carrying  
 21 out telecommunications demonstrations.

22       “(b) The Secretary may approve an application sub-  
 23 mitted under subsection (a) if he determines—

24                               “(1) that the project for which application is made  
 25 will demonstrate innovative methods or techniques of

1 utilizing nonbroadcast telecommunications equipment or  
2 facilities to satisfy the purpose of this section;

3 “(2) that demonstrations and related activities as-  
4 sisted under this section will remain under the admin-  
5 istration and control of the applicant;

6 “(3) that the applicant has the managerial and  
7 technical capability to carry out the project for which  
8 the application is made; and

9 “(4) that the facilities and equipment acquired or  
10 developed pursuant to the application will be used sub-  
11 stantially for the transmission, distribution, and deliv-  
12 ery of health, education, or public or social service  
13 information.

14 “(c) Upon approving any application under this sec-  
15 tion with respect to any project, the Secretary shall make  
16 a grant to or enter into a contract with the applicant in an  
17 amount determined by the Secretary not to exceed the  
18 reasonable and necessary cost of such project. The Secretary  
19 shall pay such amount from the sum available therefor, in  
20 advance or by way of reimbursement, and in such install-  
21 ments consistent with established practice, as he may  
22 determine.

23 “(d) Funds made available pursuant to this section  
24 shall not be available for the construction, remodeling, or  
25 repair of structures to house the facilities or equipment ac-

1 quired or developed with such funds, except that such funds  
2 may be used for minor remodeling which is necessary for  
3 and incident to the installation of such facilities or equip-  
4 ment.

5 “(e) For purposes of this section, the term ‘nonbroad-  
6 cast telecommunications facilities’ includes, but is not limited  
7 to, cable television systems, communications satellite systems  
8 and related terminal equipment, and other methods of trans-  
9 mitting, emitting, or receiving images and sounds or intel-  
10 ligence by means of wire, radio, optical, electromagnetic or  
11 other means.

12 “(f) The funding of any demonstration pursuant to this  
13 section shall continue for not more than three years from the  
14 date of the original grant or contract.

15 “(g) The Secretary shall require that the recipient of  
16 a grant or contract under this section submit a summary and  
17 evaluation of the results of the demonstration at least an-  
18 nually for each year in which funds are received pursuant to  
19 this section.

20 “(h) There are authorized to be appropriated \$1,000,-  
21 000 for the fiscal year ending June 30, 1976, and \$250,000  
22 for the period July 1, 1976, through September 30, 1976, to  
23 carry out the provisions of this section. Sums appropriated  
24 under this subsection for any fiscal year or period shall remain

1 available for payment of grants or contracts for projects for  
2 which applications approved under this section have been  
3 submitted within one year after the last day of such fiscal  
4 year or period.”.
