AN ACT

To amend the Communications Act of 1934 to provide continued financing for the Corporation for Public Broadcasting.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*
3 That this Act may be cited as the "Public Broadcasting
4 Financing Act of 1970".

5 SEC. 2. Subsection (k) of section 396 of the Com-
6 munications Act of 1934 (47 U.S.C. 396 (k)) is amended
7 to read as follows:

8 “(k) (1) There are authorized to be appropriated for
9 expenses of the Corporation for the fiscal year ending June
10 30, 1969, the sum of \$9,000,000, and for the fiscal year

1 ending June 30, 1970, the sum of \$20,000,000, and for each
2 of the next three fiscal years such sums as may be necessary.

3 “(2) In addition to the sums authorized to be appropri-
4 ated by paragraph (1) of this subsection, there are author-
5 ized to be appropriated for payment to the Corporation for
6 each fiscal year during the period July 1, 1970, to June 30,
7 1973, amounts equal to the amount of total grants, donations,
8 bequests, or other contributions (including money and the
9 fair market value of any property) from non-Federal sources
10 received by the Corporation under section 396 (g) (2) (A)
11 of this Act, during each fiscal year.”

12 SEC. 3. Section 399 of the Communications Act of 1934
13 is amended by inserting “(a)” after “SEC. 399.” and by
14 inserting at the end thereof a new subsection as follows:

15 “(b) In order to assure compliance with this section
16 and with other provisions of this Act requiring fair treatment
17 of matters in the public interest, the Commission shall pre-
18 scribe such regulations as may be appropriate to require that
19 broadcast stations which receive assistance under this title
20 (1) keep records, including audio recordings, for a reason-
21 able period of time of each program broadcast which involves
22 an issue of public importance, and (2) furnish such records

1 to the Commission at its request. The Commission shall make
2 such records available to the public at the requesting party's
3 cost under such circumstances and conditions as may be rea-
4 sonable and appropriate."
