## AMENDMENTS

Intended to be proposed by Mr. ROTH to S. 3044, a bill to amend the Federal Election Campaign Act of 1971 to provide for public financing of primary and general election campaigns for Federal elective office, and to amend certain other provisions of law relating to the financing and conduct of such campaigns, viz:

1       On page 78, line 16, strike out the closing quotation  
2 marks and the second period.

3       On page 78, between lines 16 and 17, insert the  
4 following:

5       “§ 618. **Limitation on out-of-State financing of congres-**  
6                                   **sional campaigns**

7       “ (a) Not more than 25 per centum of the amount paid

1 or incurred by a candidate for nomination for election, or  
2 for election, to the office of Senator, Representative, Dele-  
3 gate, or Resident Commissioner in connection with his cam-  
4 paign for nomination or in connection with his campaign  
5 for election may be derived from amounts contributed by—

6 “(1) individuals who reside outside of the State in  
7 which that candidate seeks nomination or election, and

8 “(2) any committee, association, or other organi-  
9 zation from funds derived from operations carried on  
10 outside of that State or from individuals who reside out-  
11 side that State.

12 “(b) Any amounts received by a candidate or any  
13 political committee authorized by him to receive contribu-  
14 tions or make expenditures which, under subsection (a),  
15 may not be used to defray expenses of his campaign shall be  
16 paid over to the Secretary of the Treasury and converted  
17 into the general fund of the United States as miscellaneous  
18 receipts.

19 “(c) A violation of any provision of this section is  
20 punishable by a fine of not more than \$25,000, imprison-  
21 ment of not more than two years, or both.”

22 On page 78, in the matter appearing after line 22, strike  
23 out the closing quotation marks and the period following  
24 them, and insert the following after the item relating to  
25 section 617:

“618. Limitation on out-of-State financing of congressional campaigns.”
