**By the Chief, Office of Engineering and Technology:**

1. On August 19, 2004, the Commission released a *Report and Order and Further Notice of Proposed Rulemaking* (FCC 04-188) in this proceeding. The following corrections are hereby made to FCC 04-188.

2. In the Table of Contents, after Section XII.E (“Initial Paperwork Reduction Act Analysis”), insert:

G. <i>Ex Parte</i> Presentations	179

3. In the Table of Contents, change Section XIII to read:

4. In paragraph 54 of the text, at the end of line 2, change “butt” to “but”.

5. In paragraph 71 of the text, at the end of line 9, change “top” to “to”.

6. In footnote 252, in the last line, change “note 237” to “note 236”.

7. In paragraph 101 of the text, at the beginning of line 20, immediately after the phrase “minutes would equal 900,000 user minutes” delete the “ (30)” that precedes the “.”. In other words, the sentence should end with the quoted phrase.

8. In the text, add to the end of paragraph 174 the following:

9. In the text, after paragraph 174, insert the following:

### **F. Comment Filing Procedures**

175. Pursuant to sections 1.415 and 1.419 of the Commission's rules, 47 C.F.R. §§ 1.415 and 1.419, interested parties may file comments on or before sixty (60) days after publication of this Notice of Proposed Rulemaking ("Notice") in the Federal Register and reply comments on or before ninety (90) days after publication of this Notice in the Federal Register. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies.

176. Comments filed through the ECFS can be sent as an electronic file via the Internet to [<http://www.fcc.gov/e-file/ecfs.html>](http://www.fcc.gov/e-file/ecfs.html). Generally, only one copy of an electronic submission must be filed. If multiple docket or rulemaking numbers appear in the caption of this proceeding, however, commenters must transmit one electronic copy of the comments to each docket or rulemaking number referenced in the caption. In completing the transmittal screen, commenters should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number. Parties may also submit an electronic comment by Internet e-mail. To get filing instructions for e-mail comments, commenters should send an e-mail to [ecfs@fcc.gov](mailto:ecfs@fcc.gov), and should include the following words in the body of the message, "get form <your e-mail address>." A sample form and directions will be sent in reply.

177. Parties who choose to file by paper must file an original and four copies of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, commenters must submit two additional copies for each additional docket or rulemaking number. Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by first-class or overnight U.S. Postal Service mail (although we continue to experience delays in receiving U.S. Postal Service mail). The Commission's contractor, Natek, Inc., will receive hand-delivered or messenger-delivered paper filings for the Commission's Secretary at 236 Massachusetts Avenue, N.E., Suite 110, Washington, D.C. 20002. The filing hours at this location are 8:00 a.m. to 7:00 p.m. All hand deliveries must be held together with rubber bands or fasteners. Any envelopes must be disposed of before entering the building. Commercial overnight mail (other than U.S. Postal Service Express Mail and Priority Mail) must be sent to 9300 East Hampton Drive, Capitol Heights, MD 20743. **G. Ex Parte Presentations**

179. In accordance with Section 1.1206 of the Commission's rules, this Notice of Proposed Rulemaking initiates a permit-but-disclose notice-and-comment rulemaking proceeding. *Ex parte* presentations are permitted, except during the Sunshine Agenda period, provided that they are disclosed in accordance with the Commission's rules.<sup>465</sup>

**10.** Renumber paragraphs 175-178 of the text to 180-183.

**11.** Revise footnotes 186 and 348 to include the updated FCC Record citation. These footnotes shall therefore read:

*In the Matter of Revision of the Commission's Rules to Ensure Compatibility with Enhanced 911 Emergency Calling Networks and Amendment of Parts 2 and 25 to Implement the Global Mobile Personal Communications by Satellite (GMPCS) Memorandum of Understanding and Arrangements et al.*, CC Docket No. 94-102 and IB Docket No. 99-67, *Report and Order and Second Further Notice of Proposed Rulemaking*, FCC 03-290, 18 FCC Rcd 25340 (2003), at ¶¶ 20-48 and 111-112 (adopting 911 service call center requirements and seeking further comment on how to implement E911 requirements for the MSS).

**12.** Revise footnote 344 to read:

We have separately adopted requirements, including information disclosure requirements, concerning aspects of spacecraft operations that may affect the ability of operators to complete appropriate satellite end-of-life procedures. *See In the Matter of Mitigation of Orbital Debris*, IB Docket No. 02-54, *Second Report and Order*, FCC 04-130, released June 21, 2004.

**13.** In Appendix E (Initial Regulatory Flexibility Analysis), renumber the paragraph that begins "*F. Steps Taken to Minimize Significant Economic Impact on Small Entities, and Significant Alternatives Considered*" to begin "*E. Steps Taken to Minimize. . .*"
