## PLEADING CYCLE ESTABLISHED FOR COMMENTS ON PETITION FOR RECONSIDERATION OF THE COMMISSION'S *FIFTH 706 REPORT*

GN DOCKET NO. 07-45

**Comments Due: September 17, 2008**

**Reply Comments Due: September 24, 2008**

On July 11, 2008, Consumers Union, Consumer Federation of America, and Free Press (Petitioners) filed a petition for reconsideration of the Commission's *Fifth 706 Report*, released on June 12, 2008.<sup>1</sup> The petition requests that the Commission reconsider its conclusion that advanced telecommunications capability is being deployed to all Americans in a reasonable and timely fashion.<sup>2</sup> Petitioners argue that the Commission failed to take certain facts and arguments into account in the *Fifth 706 Report*, including that "nearly all the commercially available broadband services in the U.S. are highly asymmetric one-way technologies."<sup>3</sup>

This matter shall be treated as a "permit-but-disclose" proceeding in accordance with the Commission's *ex parte* rules. See 47 C.F.R. §§ 1.1200, 1.1206. Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentations must contain summaries of the substance of the presentations and not merely a listing of the subjects discussed. More than a one or two sentence description of the views and arguments presented generally is required. See 47 C.F.R. § 1.1206(b). Other rules pertaining to oral and written *ex parte* presentations in permit-but-disclose proceedings are set forth in Section 1.1206(b) of the Commission's rules, 47 C.F.R. § 1.1206(b).

Pursuant to sections 1.415 and 1.419 of the Commission's rules, 47 C.F.R. §§ 1.415, 1.419, interested parties may file comments on or before **September 17, 2008**, and reply comments on or before **September 24, 2008**. All pleadings should reference **GN Docket No. 07-45**.
