

RE: REQUEST FOR EXEMPTION FROM COMMISSIONS'S CLOSED CAPTIONING RULES

New Beginning Ministries is on local TV once a week for 30 minutes with a program known as In His Image. The purpose of this petition is to request an exemption from the Closed Captioning Requirements, under Section 79.1 of the Commission's rules, 47 C.F.R. and 79.1. New Beginning Ministries believe their program, "In His Image", qualifies for exemption for the following reasons:

Part 79.1 Section (D)

Item (8) "In His Image" is a locally produced and distributed non-news program with no repeat value. The program is of local public interest, is not a news program, and the "electronic news room" technique of captioning is unavailable.

Part 79.1 - Section (F)

Compliance would impose an undue burden to New Beginning Ministries for the following reasons:

1. It would be necessary to send the programs to an outside source for captioning. This would impact meeting airdate deadlines and the added production cost would make production unaffordable.
2. New Beginning Ministries would have to discontinue our program and cease broadcast operations.
3. New Beginning Ministries is a donor supported, non-profit organization and the added cost would be an undue burden on the ministry at this time.
4. New Beginning Ministries total income from all sources is less than \$60,000 per year.

Again we respectfully request that New Beginning Ministries be exempted from the closed captioning requirement for the above stated reasons. We may be reached at:



Affidavit of Costs

I, Mary Lou Houllis, business manager of New Beginning Ministries, by my signature affixed to this document, do hereby make the following statement of fact and affirm:

1. Total Income of New Beginning Ministries, including all sources, \$60,000 yearly.
2. The amount paid Christian Television Network for the weekly show is the sum of \$750 per week, total expenditure for television show is \$39,000 yearly.
3. All other costs involved in the television show are performed by myself and members of the church with no charge.
4. The income of New Beginning Ministries, Inc. is so small that salaries are not paid to it's ministers.
5. Captioning costs would average \$300 per weekly show, if we had the equipment to accomplish things.
6. Total members in New Beginning Ministries church is approximately 60.
