

Commission's Secretary:

Thank you for taking the time to request further information on our petition for closed captioning exemption. As requested I have enclosed our complete financial information for 2005 on our television program "Carolina Cooking". I have also enclosed a copy of our previous petition to allow easy reference.

You have also asked me to discuss the nature and costs associated with captioning our show "Carolina Cooking", and explain reasonable alternatives to captioning, if any. For close to a year I have researched and explored opportunities to close caption our show "Carolina Cooking". There are two options that exist:

- 1.) The first way to create the captions for "Carolina Cooking" is to outsource the closed captioning work to a company that specializes in closed captioning. Because the Monday through Friday show is shot in a live to tape format and is unscripted, there is a cost to transcribe the verbiage of the program. There is also a cost to convert the text to line 21. And there is a cost to make the necessary tape copies of the program so that we can distribute the show to the ten television stations that carry "Carolina Cooking". The best price I have found is \$51.50 per tape. Please see the enclosed quote from Visual Data. By multiplying the number of weekdays in a year, 260 ("Carolina Cooking" is run Monday through Friday), by the number of stations carrying the program and needing the tapes, 10, by the amount per tape, \$51.50, the total cost for outsourcing the closed captioning of "Carolina Cooking" is reached. This total is \$133,900.00. The entire annual income for the program is only \$76,510.00. Creating the captioning for "Carolina Cooking" in this way is not a possibility.
- 2.) The second way to close caption "Carolina Cooking" is to create the captioning in-house. We would first need to purchase the correct equipment. The software to convert the text to line 21 and the new output card to connect to the decks we use will cost \$6,535.00. Please see the enclosed quote from MBS. We will also need a new video router and amplifier to connect the



2. Cont.) Beta SP decks because our current splitter will not carry line 21. The cost for this new video router and amplifier is \$918.55. Please see the enclosed quote from B&H Photo. We will also need an extra 1000 gigabytes of computer drive space to hold the captioned television programs. The cost of these drives is \$972.88. Please see the quote from MacMall.

The major cost to do the captioning in-house is the labor. Because the Monday through Friday show is shot as a live to tape format and is unscripted, we will need to provide someone to transcribe the verbiage of the program. Next the operator must convert the text to the captioning on line 21 through the computer software, as well as to sync the captions to the spoken words of the program. Finally, the operator needs to render the captioned television show on the computer system so that line 21 can be viewer in closed captioning. Having tested both the software and the entire process of captioning a full episode of "Carolina Cooking", I have learned that it will take roughly 5.5 hours to fully caption each program (2 hours to transcribe, a half hour to encode the text, 1.5 hours to sync the captions and 1.5 hours to render to television episode). The average wage of my video workers is \$22.50 an hour. The total cost for the labor (5.5 hours multiplied by 260 episodes multiplied by \$22.50) is \$32,175.00. When considering the new equipment, this brings the total cost of creating the captioning in-house to \$40,601.43. Considering the entire income for the show is \$76,510.00, creating the captioning in-house would require more than 53% of the show's income. This expense will create an undue burden on "Carolina Cooking".

The television program "Carolina Cooking" features the chefs of locally owned restaurants from through out the Carolinas and educates the public on creating nutritious, quality meals, from scratch, in their own homes. Having to spend more than half of the program's income on closed captioning will force "Carolina Cooking" off the air. This will cause the crew members of the television program to lose their jobs.


A reasonable alternative to captioning "Carolina Cooking," is to allow the program to continue in its current form, because *hearing impaired viewers can already follow, understand and benefit from the program.* The hearing impaired viewers of "Carolina Cooking" can currently follow and understand the program due to the step-by-step directions, instructions and recipes graphically posted in the lower third of the screen.



Because of the extreme stress and undue burden the requirement of closed captioning will place on the television program "Carolina Cooking," I formally petition you to grant "Carolina Cooking" an extension from the closed captioning requirements.

Please consider this our formal petition for closed captioning exemption on the basis of undue burden.

I own and operate a small video production company called Guerrilla Productions. We create a television program entitled "Carolina Cooking." This half hour, Monday – Friday, barter program is syndicated to 11 television stations in the Carolinas. The program featured different chefs from through out the Carolinas and educates the public on creating nutritious, quality meals, from scratch, in their own homes. Viewers can also follow along – even with their television's volume turned off – due to the step-by-step directions, instructions and recipes graphically posted in the lower third of the screen.

Because our program is produced in a "live to tape" format, there are no written scripts. I truly believe that the staff time and equipment required to create the closed captioning for "Carolina Cooking" will place a devastating stress and undue burden on our fledgling television program.

Under the Federal Communication Commission's rules for closed captioning, Section 79.1(d) EXEMPTIONS TO THE CLOSED CAPTIONING REQUIREMENTS ON THE BASIS OF UNDUE BURDEN, there are three paragraphs that apply to the situation.

(8) Locally produced and distributed non-news programming with no repeat value. Programming that is locally produced by the video programming distributor, has no repeat value, is of local public interest, is not news programming, and for which the "electronic news room" technique of captioning is unavailable.

"Carolina Cooking" is locally produced, taped, edited and distributed. Local television stations broadcast the show. Even the chefs featured on the television program are local. Because, "Carolina Cooking" is a cooking show it definitely not a news program, and the "electronic news room" technique is absolutely unavailable.

(11) Captioning expense in excess of 2% of gross revenues. No video programming provider shall be required to expend any money to caption any video programming if such expenditure would exceed 2% of the gross revenues received from that channel during the previous calendar year.

Guerrilla Productions is a small company. The program "Carolina Cooking" is not broadcast to a large area. The television program's current, as well as past season's, gross revenues reflect this. The expense of close captioning "Carolina Cooking" is drastically in excess of 2% of the gross revenues. I am willing to provide financial documentation of both the gross revenues of Guerrilla Productions and "Carolina Cooking" upon request.

(12) Channels producing revenues of under \$3,000,000. No video programming provider shall be required to expend any money to caption any channel of video programming producing annual gross revenues of less than \$3,000,000 during the previous calendar year other than the obligation to pass through video programming already captioned when received pursuant to paragraph (c) of this section.

As stated above, Guerrilla Productions is a small company and "Carolina Cooking" is broadcast on only a few stations. The revenues of "Carolina Cooking" are significantly below \$3,000,000.

When making your decision please keep in mind, hearing impaired viewers can already follow the recipes and actions on our program "Carolina Cooking" due to the written step-by-step instructions graphically posted on the lower third of their television screen.

Thank you for your time and consideration.





Please consider this our formal petition for closed captioning exemption on the basis of undue burden.

I own and operate a small video production company called Guerrilla Productions. We create a television program entitled "Carolina Cooking." This half hour, Monday – Friday, barter program is syndicated to 11 television stations in the Carolinas. The program featured different chefs from through out the Carolinas and educates the public on creating nutritious, quality meals, from scratch, in their own homes. Viewers can also follow along – even with their television's volume turned off – due to the step-by-step directions, instructions and recipes graphically posted in the lower third of the screen.

Because our program is produced in a "live to tape" format, there are no written scripts. I truly believe that the staff time and equipment required to create the closed captioning for "Carolina Cooking" will place a devastating stress and undue burden on our fledgling television program.

Under the Federal Communication Commission's rules for closed captioning, Section 79.1(d) EXEMPTIONS TO THE CLOSED CAPTIONING REQUIREMENTS ON THE BASIS OF UNDUE BURDEN, there are three paragraphs that apply to the situation.

(8) Locally produced and distributed non-news programming with no repeat value. Programming that is locally produced by the video programming distributor, has no repeat value, is of local public interest, is not news programming, and for which the "electronic news room" technique of captioning is unavailable.

"Carolina Cooking" is locally produced, taped, edited and distributed. Local television stations broadcast the show. Even the chefs featured on the television program are local. Because, "Carolina Cooking" is a cooking show it definitely not a news program, and the "electronic news room" technique is absolutely unavailable.



(11) Captioning expense in excess of 2% of gross revenues. No video programming provider shall be required to expend any money to caption any video programming if such expenditure would exceed 2% of the gross revenues received from that channel during the previous calendar year.

Guerrilla Productions is a small company. The program "Carolina Cooking" is not broadcast to a large area. The television program's current, as well as past season's, gross revenues reflect this. The expense of close captioning "Carolina Cooking" is drastically in excess of 2% of the gross revenues. I am willing to provide financial documentation of both the gross revenues of Guerrilla Productions and "Carolina Cooking" upon request.


(12) Channels producing revenues of under \$3,000,000. No video programming provider shall be required to expend any money to caption any channel of video programming producing annual gross revenues of less than \$3,000,000 during the previous calendar year other than the obligation to pass through video programming already captioned when received pursuant to paragraph (c) of this section.

As stated above, Guerrilla Productions is a small company and "Carolina Cooking" is broadcast on only a few stations. The revenues of "Carolina Cooking" are significantly below \$3,000,000.

When making your decision please keep in mind, hearing impaired viewers can already follow the recipes and actions on our program "Carolina Cooking" due to the written step-by-step instructions graphically posted on the lower third of their television screen.
