




## EXPLANATION OF PAPER FILING AND REQUEST FOR WAIVER

Cook Inlet GSM, Inc. ("CIGSM") and VoiceStream Wireless Corporation ("VoiceStream") hereby request a waiver of Section 1.913(b) of the Commission's rules, 47 C.F.R. § 1.913(b), which generally requires that all applications filed on FCC Form 603 be filed electronically. There is good cause for the requested waiver. Many of the licenses involved in the transactions among CIGSM, Cook Inlet Telecommunications, Inc. and VoiceStream that are the subject of this transfer of control application and other transfer of control applications being filed simultaneously herewith are either (a) the subject of other, unrelated applications that are currently pending before the Commission or (b) are included within the Commission's Universal Licensing System ("ULS") electronic database but the status of these licenses are either incorrect or not final with respect to ULS. For one of these two reasons, it is not possible to file an electronic application which correctly reflects the number and status of licenses involved in the instant transaction. CIGSM and VoiceStream therefore request a waiver of the Commission's electronic filing requirements in order that all of the relevant transfer of control applications can be submitted and considered simultaneously.

In the case of the instant application, regarding the transfer of control of Cook Inlet/VoiceStream License Company, LLC ("CIVS License"), the ULS database does not currently reflect a consummation notice that was filed by CIVS License on May 8, 2000, notifying the Commission that certain licenses had been assigned to CIVS License from Cook Inlet/VoiceStream PCS, LLC ("CIVS I") on April 28, 2000, in accordance with the pro forma application granted by the Commission with respect to such assignment. See File No. 0000075402. Although CIVS License had submitted the appropriate consummation notice, and printed out a copy of that notice once it had been submitted, the record regarding the consummation notice does not exist in the ULS database and, indeed, the same file number printed on the submitted consummation notice has been assigned to a different, and completely unrelated, application. CIVS License has provided a copy of the submitted consummation notice to the Commission staff, but the status of the CIVS License licenses have not yet been resolved and will not be resolved in time to file this application electronically.

## EXPLANATION OF PAPER FILING AND REQUEST FOR WAIVER

Cook Inlet GSM, Inc. ("CIGSM") and VoiceStream Wireless Corporation ("VoiceStream") hereby request a waiver of Section 1.913(b) of the Commission's rules, 47 C.F.R. § 1.913(b), which generally requires that all applications filed on FCC Form 603 be filed electronically. There is good cause for the requested waiver. Many of the licenses involved in the transactions among CIGSM, Cook Inlet Telecommunications, Inc. and VoiceStream that are the subject of this transfer of control application and other transfer of control applications being filed simultaneously herewith are either (a) the subject of other, unrelated applications that are currently pending before the Commission or (b) are included within the Commission's Universal Licensing System ("ULS") electronic database but the status of these licenses are either incorrect or not final with respect to ULS. For one of these two reasons, it is not possible to file an electronic application which correctly reflects the number and status of licenses involved in the instant transaction. CIGSM and VoiceStream therefore request a waiver of the Commission's electronic filing requirements in order that all of the relevant transfer of control applications can be submitted and considered simultaneously.

In the case of the instant application, regarding the transfer of control of Omnipoint Atlantic City License, LLC, the ULS database has not been updated to reflect the consummation notice filed with respect to the *pro forma* assignment of the license from CIVS II to Omnipoint Atlantic City License, LLC.<sup>1</sup> See File No. 0000117731. Because the status of the license has not been updated in the ULS database, this transfer of control application is being filed by paper.
