Frequently Asked Questions

How do I log into LMS?

We recommend that applicants use Google Chrome, Mozilla Firefox, or Microsoft Internet Explorer to access LMS, which can be found at: <u>https://enterpriseefiling.fcc.gov/dataentry/login.html</u>.

To log in to LMS, you must have an FCC Registration Number (FRN) and the password associated with that FRN. Unlike the CDBS system, all filings in LMS are tied to a facility's FRN. Applicants that need to reset their FRN password should contact the help desk at 1-877-480-3201. If the licensee, permittee, or applicant does not have an FRN, it may create one through the FCC's CORES system: https://apps.fcc.gov/cores/userLogin.do.

Open a Web browser and navigate to <u>https://enterpriseefiling.fcc.gov/dataentry/login.html</u>. In the **Log In** box at the upper right-hand corner of the screen, enter your FRN and password and then click the Log In button.

How do I navigate within LMS?

After logging in, you will see three tabs (Applications, Authorizations, Facilities) at the top of the page which enable you to view and file applications and reports, as well as view the status of authorizations and facilities. If you wish to view only applications or records relating to a specific Facility ID Number (FID) associated with your FRN, you may select it from the Facility ID pull-down menu on the right side of the screen. You may also search by typing a file number into the text Search box "Find Applications" next to the Facility ID menu.

The **Applications** tab at the top of the screen enables you to view the status of any applications or reports you have filed or have started without filing. From this screen and the sub-screens described below, you can amend submitted applications that are pending with the Commission, view disposed applications that the Commission has acted upon, and view and amend different reports that have been filed. Clicking the Applications tab will take you first to the Saved Applications screen. Tabs below the "File an Application" button allow you to select which applications you can view:

- "Saved" takes you to the Saved Applications screen, which displays any applications that you have created and saved but not yet filed. To access a Saved Application, click on "Not Assigned" in the File Number column for the particular Saved Application. You should review any displayed applications to ensure that they are completed and filed before applicable filing deadlines.
- "Submitted" takes you to the Pending Applications screen, which displays any applications that you have filed but that have not yet been disposed of by Media Bureau staff. You can filter by application Status (Submitted, Pending, etc.) by choosing a status from the pull-down "Status" menu at the right side of the screen. You may click on the application File Number to amend the application.
- "Disposed" takes you to the Disposed Applications screen, which displays any applications that have been filed and have been disposed of by Media Bureau staff. You can filter by application Status (Granted, Dismissed, etc.) by choosing a status from the pull-down "Status" menu at the right side of the screen. To view a PDF copy of the Disposed Application, click on the Adobe[®] icon at the far left of the line for the application you wish to view.
- "Reports" takes you to the Reports screen, which displays any reports (for example, EEO reports) that you have filed. You may click on the file number associated with a listed report to amend that report.
- "Assignment/Transfers" takes you to the Assignment/Transfer Applications screen, which displays any assignment or transfer applications that you have filed. Click on the File Number of a particular assignment or transfer of control application to see an Application Summary of that application.

The **Authorizations** tab at the top of the screen allows you to view all authorized (permitted or licensed) facilities associated with your FRN. Clicking this tab will take you first to the Active Authorizations screen. By selecting the **Authorizations** tab, a display of both the Active and Inactive Authorizations of facilities that are associated with the log-in FRN will be displayed. The default display is 25 records per screen, but you have the option in the drop-down to display up to 100 records per screen. If multiple facilities are associated with the FRN you can search a

specific facility by using the Facility ID drop-down menu or by typing the file number of a specific Authorization in the "Find Authorizations" text box. Tabs below the "File an Application" button allow you to select which authorizations you can view:

- "Active" takes you to the Active Authorizations screen, which displays all facility authorizations associated with your FRN that are currently valid. It also displays the file number of the most recent authorizing application.
- "Inactive Main DTV License" takes you to the Active Authorizations screen, but displays only inactive Digital Television licenses associated with your FRN.
- "Inactive FM Main Station" takes you to the Active Authorizations screen, but displays only inactive full-service FM facilities associated with your FRN. Examples might include facilities that have been applied for but not yet authorized; authorizations that have been surrendered; and authorizations that have been modified or have expired.

Facilities Tab

The **Facilities** tab at the top of the screen allows you to view all facilities, active or inactive, that are associated with the log-in FRN. Clicking this tab will take you to the Facilities screen. There are no sub-screens. You may search for a specific facility on the right or you may also display up to 100 facilities per page.

How do I file a license renewal application in LMS?

LMS will eventually replace CDBS as the licensing and application filing system for all Media Bureau applications, both Video and Audio. At the moment, Audio Division applicants can only file FCC Form 2100, Schedule 303-S (formerly FCC Form 303-S), Renewal of Broadcast Station License, in LMS. Audio Division applicants can and must also submit FCC Form 2100, Schedule 396 (formerly FCC Form 396), Broadcast EEO Program Report, in LMS. When submitting Schedule 396, the EEO report, the applicant must make sure to copy the File Number assigned by LMS to the EEO report, as this will need to be entered in Schedule 303-S, Renewal of Broadcast Station License.

Filing Schedule 396, Broadcast EEO Program Report:

- 1. Click on the **Facilities** tab at the top of the page
- 2. Click the Facility ID Number of the licensed facility you wish to renew. This will bring you to the main page for the selected station.

Some applicants (for example, LPFM, FM translators) need not complete and file Schedule 396, Broadcast EEO Program Report. If you are required to file Schedule 396, you must copy the File Number assigned by LMS to the Schedule 396, Broadcast EEO Program Report. You will enter this File Number in Schedule 303-S, Renewal of Broadcast Station License, when you answer "Yes" to the question under "EEO Program" asking whether you have filed the EEO Broadcast Program Report. A text box will open labeled "Enter File Number" when you respond "Yes" to the question; enter the LMS-assigned Schedule 396 File Number in the box.

LMS will "pre-fill" the General and Applicant/Contact Information sections of Schedule 303-S from information in the Commission's database, although applicants will be able to amend or update that information. Because this information will be imported into LMS from the existing data in CDBS, the need to update information is to be expected, and applicants are strongly encouraged to carefully check the information for accuracy.

Where do I find the LMS Public Database Tables for Downloading?

On the Homepage of the FCC Licensing and Management System you will select "LMS Public Database Files" under the LMS Database Section.



Can I partially complete my application and return to it later to complete it and file?

Yes, however, if you have a critical error in one of the sections, the information you entered will not be saved when you log out. If you have a non-critical error in one of the sections, the information you entered will be saved when you log out.

Can I successfully file my application if I have a pending error?

As you fill out each section of the application, when you click on the "Save & Continue" button, the system will check for errors based on your answers to the questions that have been provided and will indicate which questions, if any, need to be corrected. You can continue to the next screen without correcting the errors in that section, however all the errors must be corrected before you can file your application successfully. If you receive a critical error in a Section, your answer to the question with the critical error will not be saved and it must be re-entered when you return to that Section.

Multiple FRN's and Station Records

Can I maintain multiple FRN numbers to use when logging in?

If your station is associated with multiple FRNs in CDBS, you can use any of them to log in. When logging into LMS for the first time with an FRN that is associated with a facility ID that had multiple associated FRNs in CDBS, the licensee will be asked to "Select (the) FRN of Record." Doing so will permanently associate the log-in FRN with the selected facilities, making that FRN the only one that may be used to file applications for those facility ID(s) in LMS. Facility IDs with only one associated FRN will not be required to select the FRN of record.

Will all the records regarding my station appear under the station records in LMS?

LMS will eventually include links to all current authorizations, which include the construction permits and license authorizations and any pending construction permit or license application for your station. These records will appear under the authorization tab. These records will be added to LMS as we transition more forms and services from CDBS to LMS.
