Please note that registration is not required for downloading and viewing the registry. The Intermediate Provider Registry is available for viewing by downloadable .CSV file by any member of the public.  - Entities with an FRN that wish to register can click the "Log In" button and proceed. See Step 4 below.
- 4. Once you have an FRN, from the Intermediate Provider Registry site screen (See Step 2, and Figure 2), you can submit an Intermediate Provider Registration by clicking the "Log in" button in the "Submit Registration" section of the screen. <u>Please note that if you are not already logged in, you will first be redirected to a screen with multiple application icons.</u> If this is the case, please click on the "IPR" icon to be directed to the internal Intermediate Provider Registry page, where you may begin your registration.
- 5. Once you arrive at the internal Intermediate Provider Registry page, click the "New" button in the Intermediate Provider listing section (see Figure 3 below), or click on an existing FRN listing in that section to edit an existing entry.

6. Once you click "New," you will arrive at a new screen prompting you for your initial information (see Figure 4 below). Note that you must list your FRN, States Serviced, Other DBA Names, and All Business Names Previously Used. Once you have entered this information, click the "Save (Ctrl + S)" button. Please note that clicking the "Save (Ctrl + S)" button at this juncture <u>DOES</u> <u>NOT</u> register you in the Intermediate Provider Registry, but merely begins the registration process. After you press "Save (Ctrl + S)," you will be redirected to the internal Intermediate Provider Registry page, where you will input your remaining registration information.

10. Once you click "New" and arrive at the New Intermediate Provider Contact page, select one of the following contact types from the "Contact Type" dropdown field: Chief Executive Officer (or equivalent), Chief Operating Officer (or equivalent), Regulatory Contact (or designated agent for service of process), Rural Call Completion Point of Contact, and Other. Note that you must submit entries for the Regulatory Contact (or designated agent for service of process), Rural Call Completion, and either the Chief Executive Officer (or equivalent) or the

Chief Operating Officer (or equivalent) entries. In accordance with the FCC's *Rural Call Completion Third Report and Order*, and associated rules, the Chief Executive Officer (or equivalent) and the Chief Operating Officer (or equivalent) entries will not appear in the public Intermediate Provider Registry. Although the listed contact for any of those entries may be the same person, separate entries for all the contact types are required. Please ensure that you enter the full address (street, state, and zip) for any address entry.
