## Explanation of Effort and Availability of Commercial Equipment

My company has conducted work on the removal of covered equipment since the submittal of the last form. NMU has removed Huawei equipment from 21 sites and scheduled equipment removal for an additional 11 sites.

My company has not conducted work on the disposal of covered equipment since the submittal of the last form. NMU continues to inventory and store its removed, covered equipment in a secure facility as it awaits final disposal.

My company has conducted work on the replacement of covered equipment and services since the submittal of the last form. NMU has completed the installation of new equipment at 21 of its LTE transmission facilities.

Yes, we are finding that equipment and services are commercially available.

While NMU has found RAN equipment and services to be generally available, construction schedules continue to be impacted by unexpected tower modifications and delays in securing NTPs due to additional site acquisition, regulatory, and mapping requirements. NMU has also encountered problems in scheduling CPE replacements due to vendor delays in securing appropriate outdoor (ODU) equipment. Additionally, the lack of full funding hampers equipment acquisition, crew scheduling and completing site replacements. NMU believes an extension to the original timeline will be required in order to complete the project as proposed. NMU remains very concerned about two items. Absent full replacement funding, the University will be unable to replace all of its Huawei equipment as proposed. Additionally, NMU is concerned about changes made to the SCRP program that require a pause in processing reimbursements while project changes are under review.
