System Certification**

NOTICE OF CERTIFICATION OF AN OPEN VIDEO SYSTEM

Miracle Attainment Corp ("OVS"), pursuant to FCC Form 1275 and section 76.1502(c) of the Commission rules, hereby submits its Notice of Certification application as an Open Video System ("OVS"). As required by section 76.1502(c), OVS respectively submits the following:

1. OVS Operator. Miracle Attainment Corp, a wholly owned division of the MiraQueRico Network, LLC, a Public Utilities Holding Company of OVS Open Video Systems and ETC Exempt Telecommunications Company assets like ETROS ETC Corp, an FCC Certified "ETC" Exempt Telecommunications Company (ETC 06-560). 3. Projected Channel Capacity. Miracle Attainment Corp is providing education, entertainment, online gaming and onsite Gaming Commission services, sports and e-sports, "EAS" information services and news over leased access fiberoptic telephone lines, Google Cloud Platform, etc. The "OVS" service will have up to 1,400 HDTV, 4K and 8K resolution channels. The channels will consist of switched circuits, linear channels. The onsite facilities-based POP point of presence and telecom 99.999 quality of service.
4. Advanced Telecommunications services. In the future, Miracle Attainment Corp may use ATSC 3.0 "OVD-OTT" Online Video Distribution and Over The Top distribution via Section 706 of the Telecom Act of 1996, FCC subsequent rulings and orders.
5. Public Rights of Way. The Public ("ROW") Rights of Way will be respected as per

States, Cities and territories as required by recent FCC Rules and Orders specific to "OVS" and "OVD".

- 6. FCC Compliance. Miracle Attainment Corp is acting in good faith in providing the above "OVS" and "OVD" "IP" distribution services in the Public's Interest, Convenience and Safety.
- 7. TAX SUPPORT Miracle Attainment Corp will support the 5% Franchise Authority gross revenue tax, if OVS is still under the jurisdiction of the Franchise Authorities PEG requirements. An additional subscribers-paid and bill-to-keep 5% gross revenue tax dedicated to supporting EAS 1st Responders crisis communications, training, rescue and mobile equipments. Such 1st Responders support will be provided by KHDTV Corp nonprofit charity and KHDTV Broadcasting ETC as the Administrator acting in the publics need, necessity, convenience and EAS safety. Furthermore, subscribers-paid and bill-to-keep 11% gross revenue tax dedicated to real-estates acquisition, transportation access and security, personnel for search and rescue, broadcast equipments, crisis communications management center (CCMC) for emergency and disaster recovery, on-site independent renewable energy sources, and infrastructures development and maintenance.




