Explanation of Effort and Availability of Commercial Equipment

*Provide an explanation of efforts undertaken, and challenges encountered, in permanently removing, replacing, and disposing of covered communications equipment or service.

We have finally overcome the issue of acquiring switches for the wireless core connection and are in the process of testing the core with the new Ericsson equipment in hopes that we will be ready to start the first Huawei removal of 2.5 equipment in February. Over the past quarter, we have obtained engineering drawings through an engineering firm for over half of the towers that we currently have Huawei equipment on. This allows us to be ready to start the first removals of the 2.5 wireless equipment with a target date of February 2024.

We have made additional progress on the FTTH equipment, where we have installed 98% of all chassis. Through a muxing process side by side with the Huawei equipment, we have been able to migrate just over 450 customers from the Huawei equipment, but we have slowed the process because of the high cost of labor associated with removing the customer's home equipment. We find that our biggest hurdle is contacting the customers and scheduling a time to remove the Huawei home equipment and installing the new Ciena home equipment replacement.

We have also been successful in getting 75% of our Huawei microwave equipment replaced over the last quarter.

We have had success with the installation of more routers because we have contractors who have been able to work alongside our team. At this point, we have installed over 80 routers in the network; however, our biggest obstacle is still migrating all the individual router traffic that exists on the old Huawei routers.

We previously indicated that the DC plant changeouts required additional outside labor. We have sourced outside contractors and over the last quarter have been successful in upgrading over 60 of our power systems without significant outages to the site equipment. In the coming quarter, we target the removal of 20 of the Huawei power systems still in parallel with installing the new equipment.

Our concern, as always, is hitting a stopping point in the coming year, given that additional funding has not yet become available. However, we will complete as much work as possible up until we run out of money.

As we have previously indicated, finding all the equipment to make cohesion of all the new equipment capable has been a challenge. At this point, we believe we have secured 95% of the switches and routers needed to begin the testing of the 2.5 wireless equipment and, subsequently, the start of the 2.5 wireless installation and replacement at the end of February.

We now have the majority of equipment needed to test and start the installation of our core 2.5 equipment and, subsequently, the swap out of the 2.5 equipment starting at the end of February.
