My company has conducted work on the removal of covered equipment since submittal of the last form. NMU has removed Huawei equipment from 11 sites and schedules equipment removal as replacement equipment is available.

My company has conducted work on the disposal of covered equipment since the submittal of the last form. NMU continues to store its Huawei equipment removed from service in a secure facility awaiting final disposal.

My company has conducted work on the replacement of covered equipment and services since the submittal of the last form. NMU has completed the installation of equipment at 11 sites.

Yes, we are finding that equipment and services are commercially available.

While NMU has found equipment and services to be generally available, construction schedules continue to be impacted by unexpected tower modifications and delays in securing NTPs due to additional site acquisition and mapping requirements. Additionally, the lack of full funding hampers equipment acquisition, crew scheduling, and completing site replacements. NMU believes an extension to the original timeline will be required in order to complete the project as proposed.

NMU remains concerned about two items. Absent full replacement funding, the University will be unable to replace all of its Huawei equipment as proposed. Additionally, NMU is concerned about changes made to the SCRP program that now require a pause in processing reimbursements while project changes are under review.
