Yes, my company has conducted work on the removal of covered equipment since submittal of the last form. Commnet has completed 2% of the removal of equipment.

Yes, my company has conducted work on the disposal of covered equipment since the submittal of the last form. We are pending contractual acceptance between our construction vendor and the vendor doing disposal.

Yes, my company has conducted work on the replacement of covered equipment and services since the submittal of the last form. We have received quotes and issued 74 purchase orders for site acquisition and permitting work, 147 purchase orders for site construction work, and have received notices to proceed on 11% of sites, and Commnet has completed site designs on 92% sites which are included in the following FRN: Commnet – CO (31735459).

We are working with multiple vendors to source the materials needed to replace the Covered Equipment. While we are finding the equipment to be commercially available, the largest impact we have encountered has been cost increases and delay in the delivery of materials. For example, cabinet delivery is currently slated for 5-6 months.

Commnet has pushed out the construction schedule to accommodate the long timelines and is focusing on getting all of the site acquisition and permitting work completed so that when equipment is delivered, it is ready to commence construction work to replace and remove the Covered Equipment.

Commnet is approximately 4% finished with the removal, replacement, and disposal process, but has not yet completed it.

Timeline Deviation - With the 40% allocation, Commnet has had to change its goal of replacing all Covered Equipment and had to re-evaluate the overall timeline and build plan. Overall completion of the project will likely extend past the timeline currently set forth for the program and imposed by statute. Funding uncertainty, sourcing of materials, and weather have negatively impacted our overall completion timeline, and scope of the proposed project.
