We are negotiating terms with the vendors that we have selected to replace and dispose the covered equipment. We expect to begin removing and replacing the covered equipment 2Q23. The reduction in reimbursement forced a re-examination of all work related to the SCRP program.

Commnet Wireless, LLC has selected Vendors and has completed contracts for 1 of 3 vendors. Commnet is very close to concluding contract negotiations for the remaining 2 vendors. Commnet has approved and are issuing 380 PO's with more coming daily. Commnet has conducted work on the removal of covered equipment. Commnet has completed RF planning on 215 sites, completed property applications on 238 sites, completed leasing on 67 sites and will start construction on 1 site this week. Timeline Deviation - We have not yet met all benchmarks laid out in the timeline, and we anticipate that the timeline no longer accurately reflects our project plan. We are starting later than we anticipated because the reduction in reimbursement forced a re-examination of all work related to the SCRP program.
