Explanation of Effort and Availability of Commercial Equipment

Country Wireless began removing and replacing its Covered Equipment in 2021. As of October 13, 2022, it has achieved the following milestones.

- 1) Replacement Core: The replacement core has been installed and integrated into the billing module. Internal staff have been trained and subscribers can now be invoiced on this new system. SAS credentials have also been updated.
- 2) Subscriber Migration: New end-user equipment has been deployed to 230 subscribers, who have migrated to the replacement core.
- 3) Replacement of Tower Equipment: Covered Equipment has been removed from and replaced on six of 33 towers. Because tower crews are difficult to find, Country Wireless has been using a bucket truck so that it can perform this work without tower crews. The use of a bucket truck is less expensive than using tower crews. It also increases safety and allows Country Wireless to work deeper into the winter months when tower climbing is not safe.
- 4) Destruction of Covered Equipment: All Covered Equipment that has been removed, including end user equipment, has been inventoried, palletized, and put into a locked storage unit.
