Explanation of Effort and Availability of Commercial Equipment

*Provide an explanation of efforts undertaken, and challenges encountered, in permanently removing, replacing, and disposing of covered communications equipment or service.

Updates on activities completed and underway during the previous period are as follows:

- Gogo is continuing to work with our vendor selected to provide replacement network components and equipment
- At this point, Gogo and the vendor have completed a formal PDR (preliminary design review) meeting for replacement network components and equipment, includina:

Cell Site Ground Network Infrastructure (equipment and systems to be replaced at existing cell sites)

Tower Antennas (antennas to be replaced on cell site towers)

- o Following from our last status report update, PDR phase exit-critical action items and questions from the completed milestone meeting have now been closed, and this phase of the project can now be considered as "exited"
- o Based on the formal exit of this project phase with the selected vendor, Gogo is now preparing to order preliminary quantities of Cell Site Ground Network Infrastructure, specifically, to support the standup and integration of labs and "test bed" cell sites, to be used for preliminary validation and testing activities in the field (as a precursor to our intended full network deployment)
- Gogo and the selected vendor are also continuing to have discussions on future phase project milestones and activities, including:

CDR (critical design review)

Lab and test bed site install(s)

- Implementation efforts are currently underway for network core and HSS (Home Subscriber Service) solutions, both of which will be required for use with the network elements and design, as part of the replacement of the currently used ZTE equipment
- Implementation for both solutions is expected to complete in the late-Q4, 2023. early-Q1, 2024 timeframe, with integration testing and validation efforts to follow
- Outside of activities and efforts with our selected vendor(s) noted above, Gogo is continuing to make progress on work related to the Airborne Equipment transition strategy for our existing customers and aircraft
- Airborne Equipment upgrade and transition activities with Gogo's customer base are currently underway – conversations, planning, and adjustments for these activities will continue throughout the lifecycle of the project
- Gogo has continued to make progress internally to define the plan and approach for requesting reimbursements from the FCC as part of the Reimbursement Program, including a proposed approach for financial reporting in coordination/alignment with reimbursement
- o Gogo's first two reimbursement requests have been submitted and confirmed as accepted, as of the time of this report
- o Discussions on this topic will likely continue throughout the program timeline, as additional reimbursement requests are submitted
- o Gogo has engaged Summit Ridge Group to assist with the reimbursement process.
- o Gogo is continuing to assess the need for modifications/amendments to our application as we begin the reimbursement process, due to:
- § Estimated cost vs. actual cost for targeted network & equipment replacement costs/catalog items
- Documentation requirements to substantiate reimbursement requests
- Modifications associated with general reimbursement execution complexity
- § § Gogo is concerned that the modification process will hold up the overall reimbursement process on other items of the application, causing delay in cash

As outlined last quarter, given that Gogo's particular application for network replacement includes parts and equipment that are not COTS (Commercial Off The Shelf), there continues to be significant effort and consideration involved to design and manufacture these items per specific requirements, as outlined above (both with our selected vendor and internally). Additional details on these efforts and associated challenges are included below:

- Gogo continues to see marginal improvement across the supply chain for Airborne Equipment materials availability and associated lead times for delivery; as was the case in our last update, constraints in this area should still be considered a key area of risk to consider for the program moving forward
- A portion of non-vendor-specific network equipment is now on-hand at Gogo, with additional equipment in this category expected to be delivered in August 2023
- o The general goal is to have all equipment for this category on-hand at Gogo, ahead of the planned arrival of vendor-specific network equipment (given lead time constraints to consider for vendor-specific equipment, noted below)
- · Given the update provided earlier in this report on progress made with our selected vendor, aspects/components of the intended replacement network (Cell Site Ground Network Infrastructure, Tower Antennas, etc.) can now be ordered since the "PDR" phase of the project has now been formally exited; efforts are currently underway to submit a purchase order for initial "lab" and "test bed" site equipment
- o Lead times for components associated with selected vendor-based network equipment are ~24 weeks additional updates and details will be provided in this regard once available from our vendor (likely, following initial PO submission with the vendor)

As outlined above, Gogo has commenced preliminary activities pertaining to program execution; mainly in the areas of equipment sourcing/ordering, reimbursement request submission, and airborne equipment/customer conversion. Despite this progress, Gogo continues to assess the impact on its Project Timeline absent further information regarding the "full funding" status of the Reimbursement Program. Gogo will also need prompt reimbursement to finance its program. As a result, there may be a need in the future to update the Project Timeline and associated milestones to reflect any potential impact to the Project Timeline that may result because of the lack of clarity regarding "full funding" of the Reimbursement Program. If the Project Timeline needs to be modified given the foregoing, Gogo will work with the FCC to ensure that any updates to the Project Timeline are understood.
