Explanation of Effort and Availability of Commercial Equipment

A. Currently, Gogo is:

- In the process of complying with all requirements of the Reimbursement Program
- In the process of complying with the commitments made originally in our application

 In the preliminary phase of the process of permanently removing, replacing, and disposing of all covered communications equipment or services that were in our network as of the date of the submission of Gogo's application

• In the process of complying with the timeline submitted in our application Further details on the "in-process" activities listed above are outlined and described in more detail throughout the other areas of this report.

While Gogo does in fact eagerly await more information on the full funding of the program, the plans established in the Project Timeline are proceeding and actions are being taken. The 1st Quarter of the Project Timeline stipulates Pre-Planning activities, and here is a list of those activities completed and underway:

Gogo has conducted Antenna Diversity testing at several existing cell sites along the east coast of the U.S.

o The underlying need for this test was to validate the potential impact to the existing service, if Gogo must partially remove some of the service-providing antennas, to support the installation of the new, replacement antennas on towers with limited space or structural capacity

o The test results from this effort met expectations, and therefore can be considered a viable option to be pursued, if required in certain scenarios

 Gogo has shared system requirements and specifications for all replacement network components with potential vendors, and those vendors have provided in response, designs for Gogo's review, to prepare for formal PDR (preliminary design review) – the following network components are considered in-scope for this review:
Cell Site Ground Network Infrastructure (equipment and systems to be replaced at existing cell sites)

o Tower Antennas (antennas to be replaced on cell site towers)

o Network Core/Datacenters (equipment and systems to be replaced in Gogo's datacenters)

§ Progress has been made to evaluate a network core solution from a preferred vendor, to serve as a suitable replacement within Gogo's network ecosystem, and platform for other network components and systems delivered from other vendors (as outlined above)

• Outside of work efforts and discussions with vendors as outlined above, Gogo is also continuing to make progress on work related to Airborne Equipment design

o These design efforts are a critical input to the overall product offering that will be used by our customers to help facilitate network transition (the key tenet of this program)

Gogo has continued to make progress internally to define the plan and approach for requesting reimbursements from the FCC as part of the SCRP program, including a proposed approach for financial reporting in coordination/alignment with reimbursement

o Discussions on this topic will likely continue throughout the reimbursement timeline

• Gogo's Production Operations team has started the ordering and procurement of certain long-lead time parts that will likely be used in the design, test, and manufacturing of replacement airborne equipment

Long-term Gogo PMO team ownership of the project has been defined, and comprehensive cross-functional planning efforts are continuing as expected

Given that Gogo's particular application for network replacement includes parts and equipment that are not COTS (Commercial Off The Shelf), there is significant effort and consideration involved to design and manufacture these items per specific requirements, as outlined above (both with vendors and internally). The following updates should help to detail and outline these efforts and associated challenges:

Chipsets and componentry for airborne equipment have significant supply chain constraints

o Orders have been placed for initial quantities of these types of parts, however, communications from vendors and suppliers have indicated lead times of ~70 weeks for delivery

Network router equipment has significant supply chain constraints

o Vendors have communicated lead times of ~52-78 weeks for delivery

o Despite these communicated lead times, network router equipment cannot be ordered until designs and integration plans have been reviewed for other aspects of the replacement network (Cell Site Ground Network Infrastructure, Tower Antennas, etc.)

• Other aspects and components of the intended replacement network (Cell Site Ground Network Infrastructure, Tower Antennas, etc.) cannot be ordered at this time, as designs are not yet complete

o It should be noted that these items will not likely be ordered until Gogo and vendors complete relevant PDR (preliminary design review) activities, and Gogo feels that the designed replacement network components can and will meet all functional and performance requirements, as defined by Gogo – long lead times are also expected for these items, but additional updates and details will be provided in this regard once available from vendors

o Full-funding guidance and updates should also be considered as necessary inputs for Gogo to determine to proceed with ordering these items

Without full funding in place, equipment and component orders have not been placed except in the most extreme cases. Upon notification of full funding, remaining long lead-time orders for equipment and componentry will be placed. Gogo will continue to follow our previously submitted and approved Project Timeline for timing guidance and sequencing for Equipment Orders, pending full funding approval and notification.

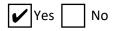
