Explanation of Effort and Availability of Commercial Equipment

LATAM has undertaken the following steps with respect to the replacement of covered equipment and services:

- (1) The company conducted a technical evaluation of the solutions of several providers to ensure that it will be able to maintain the same functionalities and guarantee a successful migration.
- (2) The company has selected the providers of replacement equipment and services.
- (3) The company is evaluating the dimensioning and acquisition of additional infrastructure for the installation of the new platform, such as power, space, cabling, servers, network equipment (routers), and additional labor.
- (3) The company is testing the replacement equipment, which includes hardware, software, functionalities, operating processes, integration to OSS and BSS systems, and training of on-site and operations center personnel.
- (4) The company is designing its migration plan and coordinating with other carriers that connect to the platform.
- (5) The company is identifying potential windows of opportunity for migration to the new equipment.
- (6) Regarding the removal of covered equipment, LATAM is working through the challenge of identifying a qualified disposal vendor that meets the FCC's guidelines for disposal of covered equipment. However, LATAM anticipates it will enter into an agreement with a qualified disposal vendor and initiate the destruction of covered equipment in the first quarter of 2023, and that the destruction of covered equipment will be completed in the second quarter of 2023.

LATAM has identified providers for replacement equipment and services. The primary challenge that the company is focused on is the standardization and configuration of data that compose and form the traffic cases that LATAM provides in a manner that is consistent with its ecosystem.
