929 and 931 MHz Paging Pre-Auction Seminar

The pre-auction seminar for the 929 and 931 MHz Paging Auction is scheduled for Friday, January 7, 2000, with registration beginning at 8:30 a.m., and the seminar ending at 4 p.m. The seminar will be held at the Federal Communications Commission, 445 12th Street S.W., Washington, D.C. Potential bidders in the auction are strongly encouraged to attend. This seminar provides an opportunity for hands-on demonstrations of the FCC filing and bidding software and access to the FCC staff responsible for the Paging service licensing and auction conduct procedures.
