# FCC Registration Number (FRN)

- To participate in FCC auctions, every qualified bidder needs an FCC Registration Number (FRN).
- To obtain an FRN, a bidder must register their Taxpayer Identification Number (TIN) using the Commission Registration System (CORES).

### **Upfront Payments Deadline**

All upfront payments must be received at Mellon Bank by 6:00 p.m. ET on October 15, 2002.

- All payments must be in U.S. Dollars.
- All payments must be made by Wire Transfer.

#### Upfront Payments (Continued)

Upfront payments for Auction #46 go to a lockbox number different from the lockboxes used in previous FCC Auctions, and different from the lockbox number to be used for post-auction payments.

Failure to deliver the upfront payment by the October 15, 2002 deadline will result in dismissal of the application and disqualification from participation in the auction.

### Making Auction Payment By Wire Transfer

Wire transfer payments must be received by 6:00 p.m. ET on October 15, 2002. To avoid untimely payments, applicants should discuss arrangements (including bank closing schedules) with their banker several days before they plan to make the wire transfer, and allow sufficient time for the transfer to be initiated and completed before the deadline.

#### FCC Form 159

Applicants must fax a completed FCC Form 159 (Revised 2/00) to Mellon Bank at (412) 209-6045 at least one hour before placing the order for the wire transfer (but on the same business day).

Detailed instructions for completion of the FCC Form 159 are included in Attachment E of Public Notice DA 02- 1871 dated August 5, 2002.
