Upfront Payments (Continued)

REMINDERS AND KEY POINTS

- Upfront Payments are due April 17, 2006 by 6:00 p.m. ET – Instructions are on Pages 24 and 25 of the Procedures Public Notice DA 06-299.
- Multiple upfront payments are permissible but a Form 159 must accompany each payment.
- Please make sure that you always use the same Applicant FRN that was used when you completed your Form 175.

- Please pay special attention to Page 37 of your Procedures PN (Post-Auction Procedures Section) At the close of the auction a public notice is released; successful bidders will have 10 business days after the release of the closing PN to meet their 1st down payment requirement of 20% of their Net Winning Bid.
- In addition, your final payment of the remaining balance is due ten (10) business days after your 1st down payment deadline.
