- *The form has been pre-filled based on the information that was provided in your FCC Form 175 Application.*

# Continued

- If you choose not to use the electronic version of the Form 159, detailed instructions for completion of the FCC Form 159 are included in Attachment D of Public Notice **DA 07-30, Dated January 16, 2007.**

For many filings the Applicant is the Payer. However, if the Payer is a third party, the Payer's FRN will be different from that of the Applicant. Enter the Payer FRN and Password below. # Upfront Payments Deadline

All upfront payments must be received at Mellon Bank by 6:00 p.m. ET on April 20, 2007

- All payments must be in U.S. Dollars.
- All payments must be made by Wire Transfer.

# Upfront Payments (Continued)

- Upfront payments for Auction #71 go to a lockbox number different from the lockboxes used in previous FCC Auctions, and different from the lockbox number to be used for post-auction payments.
- Applications to participate in the auction will not be accepted if you fail to deliver the upfront payments by the April 20, 2007 deadline.

# Making Auction Payment By Wire Transfer

To avoid untimely payments, applicants should discuss arrangements (including bank closing schedules) with their banker several days before they plan to make the wire transfer, and allow sufficient time for the transfer to be initiated and completed before the deadline.

# REMINDERS AND KEY POINTS

- Upfront Payments are due April 20, 2007 by 6:00 p.m. ET – Instructions are on Pages 26 and 27 of the Procedures Public Notice DA 07-30.
- Multiple upfront payments are permissible but a Form 159 must accompany each payment.
- Please make sure that you always use the same Applicant FRN that was used when you completed your Form 175.

- Please pay special attention to Page 44 of your Procedures PN (Post-Auction Procedures Section) At the close of the auction a public notice is released; successful bidders will have 10 business days after the release of the closing PN to meet their down payment requirement of 20% of their Net Winning Bid.
- In addition, your final payment of the remaining balance will be due ten (10) business days after your down payment deadline.
