## *(Deadlines are Deadlines)*

- 📄 FCC Form 175 Remedial Filing Window Opens: **June 24**
- 📄 Remedial Filing Window closes: **July 8**
- 📄 Upfront Payments due: **August 12**
- 📄 Mock Auction: **September 12**
- 📄 Auction Begins: **September 14**

# FCC Form 175

## Remedial Filing Window

*(Deadline – July 8th 6:00 PM ET)*

- Can be reviewed and updated electronically
- Remedial Filing window opens **June 24, 2005** at **12:00 PM ET** and will close at **6:00 PM ET** on **July 8, 2005**
- Instructions are provided in the Procedures PN (DA 05-1337, rel. 5/20/05)
- Review and update application early
- Auction specific questions, call 717-338-2868
- Technical Support, call 877-480-3201 option nine or 202-414-1250

# Status Public Notice

*(Sent by FedEx)*

- Released approximately 3 weeks after Form 175 remedial filing deadline
- Lists Accepted, Incomplete and/or Rejected applications, as well as construction permit selections
- Applicants with incomplete applications receive approximately 1 week to remedy their applications

Sent to the contact person at the contact address as indicated on Form 175

# Upfront Payments

*(Deadline – August 12th 6:00 PM ET)*

- Wire Transfer Only
- Fax FCC Form 159 to Mellon Bank at least one hour before sending wire transfer
- Submit early and confirm payment receipt with **your** financial institution

# Bidding Options

## *(Electronic or Telephonic)*

- Qualified bidders may bid electronically or telephonically
- FCC encourages electronic bidding
- If bidding telephonically, call early in the bidding period

# Qualified Bidder Public Notice

*(FedEx Mailing)*

- Released approx. 3 weeks after resubmission and upfront payment deadline

Sent to the contact person at the contact address as indicated on Form 175

- ☐ *Construction permit selections*
- ☐ *Bidding schedule for Mock Auction and first day of actual auction*
