**WINNING BIDDERS IN THE AUCTION OF  
AUTHORIZATIONS TO PROVIDE MULTIPOINT DISTRIBUTION SERVICE  
IN 493 BASIC TRADING AREAS:  
Down Payments Due April 5, 1996,  
FCC Form 304s/Statements of Intention Due May 10, 1996**

On March 28, 1996, the Federal Communications Commission completed its auction of authorizations to provide single channel and multichannel Multipoint Distribution Service (collectively referred to as MDS) in 493 Basic Trading Areas (BTAs) and BTA-like areas, raising a net total of \$216,316,333. The winning bidders and the authorizations associated with each winning bidder are listed in Attachment A. This public notice provides for winning bidders details concerning down payments, filing requirements for FCC Form 304 or statements of intention, withdrawal payments, final payments, grant of authorizations, and other post-auction procedures.

## **Down Payments**

Each winning bidder must submit to Mellon Bank sufficient funds to bring its total deposits with the government to a certain percentage (set out below) of the sum of its winning bids by **April 5, 1996**.<sup>1</sup> All down payments must be accompanied by a completed FCC Remittance Advice Form (FCC Form 159).

Winning bidders who qualify as small businesses are eligible for a reduced down payment, and must submit additional funds to bring their total deposits with the government to ten percent (10%) of the sum of their winning bids less the applicable fifteen percent (15%) bidding credit.

<sup>1</sup> In the event that a bidder has withdrawn a bid(s) and is subject to a bid withdrawal payment(s), the bidder's upfront payment will first be applied to satisfy the withdrawal payment(s) before being applied toward its down payment. If the amount of the withdrawal payment cannot yet be determined, the bidder will be required to make a deposit of twenty percent (20%) of the withdrawn bid amount. When it becomes possible to calculate and assess the penalty, any excess deposit will be refunded.

Other winning bidders must bring their total deposits to twenty percent (20%) of the sum of their winning bids. See 47 C.F.R. § 21.955.

Winning bidders for multiple authorizations must calculate the down payment applicable to each BTA authorization separately, by prorating the upfront payment on the basis of the amount of each winning bid relative to the sum of its winning bids. Winning bidders should round that percentage to the nearest one percent.

The following examples show how down payments are calculated:

**All payments must be made in U.S. dollars, must be in the form of a wire transfer or cashier's check, and must be made payable to the "Federal Communications Commission" or "FCC." No personal checks or other forms of payment will be accepted.**

**Cashier's checks must be drawn on a financial institution whose deposits are insured by the Federal Deposit Insurance Corporation (FDIC). **Wire transfer** payments must be received by **6:00 p.m. Eastern Time, April 5, 1996**. Bidders making payments by wire transfer should allow sufficient time for the wire transfer to be initiated and for the transmission to be completed prior to the deadline. Bidders making payments by wire transfer must fax a completed FCC Form 159 to Mellon Bank at (412) 236-5702 at least one hour prior to placing the order for the wire transfer (but on the same business day).

Proper completion of **FCC Form 159** is critical to ensuring correct credit of bidder deposits. Bidders must use the same FCC account number associated with their upfront payment. (This number is shown on Attachment A.) Bidders must also specify each authorization for which it was a high bidder as a separate item on FCC Form 159 (use continuation sheet FCC 159-C if necessary). And bidders must include the BTA Market Number designation **for each authorization** (as shown in Attachment A) in Block 18B of FCC Form 159.

Additional instructions and addresses for making auction payments are contained in the FCC Forms and Instructions section (pages 83-85) of the Bidder Information Package for this auction. Questions concerning the calculation and submission of down payments should be

directed to Regina Dorsey, Chief of the Billings and Collections Branch, at (202) 418-1995 during normal business hours.

Winning bidders who do not submit the required down payment by the specified deadline will be considered in default, and the Commission will determine whether the authorization in question will be offered to the next highest bidders (in descending order) or re-auctioned. In addition, defaulting winning bidders are subject to additional payments for default. Specifically, an entity in default will be assessed a payment equal to the difference between its winning bid and the winning bid the next time the authorization is offered by the Commission. An additional payment equal to three percent (3%) of the lesser of the subsequent winning bid or the defaulting bidder's winning bid will also be assessed. *See* 47 C.F.R. § 21.959.

### **Bidders Owing Withdrawal Payments**

A list of bidders who owe withdrawal payments and the amounts due appear in Attachment B. **Any withdrawal payments due will be subtracted from the bidders' upfront payments on deposit.** If a bidder's upfront payment amount is insufficient to cover the withdrawal payment due, the bidder will be expected to deposit the difference due, in addition to the full down payment discussed above, with Mellon Bank by **April 5, 1996**. If the upfront payment is larger than the withdrawal payment, any excess upfront payment funds will be credited toward the down payment or refunded, as appropriate.

### **Anti-Collusion Rules**

To insure the integrity of its auctions, the Commission's anti-collusion rules generally prohibit bidders for the same BTA authorizations from discussing bids or bidding strategies during the course of the auction. The prohibition began when short-form applications to participate in the auction were filed, and end when the winning bidders submit their down payments. For small business winning bidders eligible for reduced down payments, the prohibition ends when they satisfy the ten percent reduced down payment requirement. *See* 47 C.F.R. § 21.953.

### **FCC Form 304 or Statement of Intention**

**By 5:30 p.m. (Eastern Time) on May 10, 1996**, the winning bidder for each authorization will be required to submit *for each authorization upon which it was a high bidder* either: (a) a completed long-form application (FCC Form 304) for an MDS station license, along with any required exhibits; or (b) a statement of intention with regard to the BTA service area, along with any required exhibits. The winning bidders and the authorizations associated with each winning bidder are listed in Attachment A. **This Public Notice constitutes official notification to winning bidders under Section 21.956 of the Commission's Rules, 47 C.F.R. § 21.956, for purposes of triggering the 30-business-day filing period for the FCC Form 304 or statement of intention.**

Winning bidders who choose to file an FCC Form 304 may do so either manually or electronically, if the electronic version of the form is available at the time of filing. (When electronic filing of FCC Form 304 becomes available, the Commission will issue a public notice with further filing instructions.) Detailed instructions for completing certain exhibits required by FCC Form 304 are included in Attachment C. Each completed FCC Form 304 must be accompanied by a \$180 filing fee and FCC Form 159, and sent to:

Winning bidders who choose to file a statement of intention must include:

- (1) A showing that additional MDS stations with average transmitted power could not be constructed in their BTAs without causing harmful interference to previously authorized or proposed MDS and ITFS facilities, which demonstrates the encumbered nature of the BTA and identifies in detail all incumbents;
- (2) A detailed description of their plans for obtaining the previously authorized or proposed MDS stations within their BTAs;
- (3) An FCC Form 430;
- (4) A drug certification; and
- (5) The same exhibits concerning the winning bidders' involvement in bidding consortia and status as designated entities that must be attached to initial FCC Form 304 applications (as described in more detail in Part II of Attachment C). *See 47 C.F.R. § 21.956.*

In both FCC Form 304 and statement of intention filings, required proprietary information may be redacted, or confidentiality may be sought pursuant to Section 0.459 of the Commission's Rules, 47 C.F.R. § 0.459. **Any such requests must be submitted manually, even if the winning bidder chooses to file electronically. If filing electronically, the winning bidder**

**must indicate in an electronic exhibit that it has a confidentiality request on file.** Requests to keep required application information confidential will be subject to strict review under our rules and will not be routinely granted.

An applicant who fails to submit the required long-form application or statement of intention by May 10, 1996, and fails to establish good cause for any late-filed submissions, shall be deemed to have defaulted and will be subject to the penalties set forth in Sections 1.2104(g) and 21.959 of the Commission's Rules. *See* 47 C.F.R. § 21.956(a).

### **Informal Objections and Petitions to Deny**

Once winning bidders file their FCC Form 304s, the Commission will review the applications. If a long-form application is found to be acceptable, the Commission will release a public notice announcing this fact, triggering the 30-day filing window for petitions to deny. All petitions to deny must comply with 47 C.F.R. §§ 1.52, 1.2108 and 21.30. *See* 47 C.F.R. § 21.957(a).

Parties wishing to comment on or oppose the issuance of a BTA authorization based upon a winning bidder's statement of intention may do so prior to the Commission's issuance of the BTA authorization. *See* 47 C.F.R. § 21.957(b).

### **Final Payment and Grant of Authorizations**

After resolving any petitions to deny or oppositions to statements of intention, and if the Commission is otherwise satisfied that a winning bidder is qualified, the Commission will release a public notice announcing that we are prepared to issue the BTA authorization. The winning bidder for that BTA (unless a small business making installment payments) will be required to make full payment of the balance of its winning bid within five business days following the public notice. The Commission will issue the BTA authorization to the winning bidder within ten business days following notification of receipt of full payment. *See* 47 C.F.R. § 21.958.

A small business winning bidder eligible for reduced down payments must bring the total amount on deposit with the Commission (including upfront payments and the initial ten percent down payment) up to twenty percent (20%) of its net winning bid(s) within five business days following release of the public notice stating that its BTA authorization(s) is ready to be issued. The Commission will issue the BTA authorization to the small business winning bidder within ten business days following notification of receipt of this additional ten percent payment. *See* 47 C.F.R. § 21.960(b).

A small business winning bidder must pay the remainder of the amount due on its authorization(s) in quarterly installment payments. Small businesses will receive an installment

payment plan schedule listing payment amounts and due dates shortly after receiving their BTA authorizations.

### **Forms Availability**

Copies of FCC Forms 159 (FCC Remittance Advice), 159-C (Advice Continuation Sheet) and 430 (Licensee Qualification Report) are included in the MDS Auction Bidder Information Package. 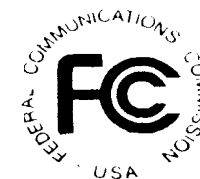

**ORGANIZATION OF LEGAL INFORMATION  
EXHIBITS FOR FCC FORM 304**

***Background***

Section II of FCC Form 304 (Application for a Multipoint Distribution Service Authorization or "long-form" application) contains provisions requiring the submission of certain legal information, including exhibits, pertaining to the ownership, control and small business status of the applicant. These long-form application provisions have been formulated pursuant to various Commission rules, including Section 21.13 (requiring full disclosure of the real party in interest to each application), Section 21.912 (restricting cable/MDS cross-ownership), and Section 21.960 (requiring small business auction winners to disclose additional ownership and gross revenue information). The following summarizes the contents of exhibits that should be submitted pursuant to Section II of the FCC Form 304.

**I. Ownership and Control of Facilities**

A. Questions 3 and 4 of Section II concern agreements affecting the ownership or control, or management or operation, of the MDS facilities proposed in the FCC Form 304. The following exhibits must be submitted in response to these questions:

1. An exhibit explaining any agreements or understandings in existence or under negotiation which affect the ownership or control of the MDS facilities proposed in the FCC Form 304, or any right or interest in such MDS facilities, by any person not a party to the FCC Form 304.

2. If any agreements or understandings in existence or under negotiation affect the management or operation of the MDS facilities proposed in the FCC Form 304, an exhibit demonstrating how the applicant will retain control over such facilities and certifying compliance with Section 21.13(g). *See* 47 C.F.R. § 21.13(g) (concerning retention of control over proposed MDS facilities by applicant where applicant does not actively participate in day-to-day management and operation of facilities).

B. Question 5 of Section II concerns the cable/MDS cross-ownership restriction set forth in 47 C.F.R. § 21.912. If the FCC Form 304 proposes a new or modified station for which there is an ownership interest in, control by, affiliation with, or leasing arrangement with a cable television company, an exhibit must be submitted describing the relationship with the cable company and a map or narrative depicting the overlap, if any, of the boundaries of the cable franchise area and MDS protected service area.

## II. Status of MDS Auction Winners

Section II of the FCC Form 304 also requires certain exhibits to be submitted with the *initial* long-form application for an MDS station within an auction winner's BTA service area, if the applicant has not previously submitted such exhibits with a statement of intention pertaining to that BTA. Questions 7 and 8 of Section II require the following exhibits to be submitted with the *initial* long-form application of an MDS auction winner, if that applicant has not previously filed a statement of intention regarding the same BTA:

A. An exhibit providing a detailed explanation of the terms and conditions and parties involved in any bidding consortia, joint venture, partnership, or other agreement or arrangement the applicant had entered into relating to the competitive bidding process prior to the time bidding was completed. *See* 47 C.F.R. §§ 1.2107(d); 21.956(b)(2). To comply with this requirement, applicants can either submit the agreements themselves, or can submit a detailed description of those agreements with proprietary information excluded.

B. If the applicant submitting its initial long-form application claimed status as a designated entity (small business or small business consortium) in the MDS auction, then the following exhibits must be submitted:

1. A list and summary of all agreements that support an applicant's eligibility as a small business, including the establishment of *de facto* and *de jure* control; such agreements include partnership agreements, shareholder agreements, management agreements and other relevant agreements, including oral agreements. *See* 47 C.F.R. §§ 1.2110(i); 21.960(e).

2. A document or series of documents that identifies all affiliates of the applicant claiming small business status. An individual or entity is an affiliate of an applicant if such individual or entity: (1) directly or indirectly controls or has the power to control the applicant; (2) is directly or indirectly controlled by the applicant; (3) is directly or indirectly controlled by a third party or parties that also controls or has the power to control the applicant; or (4) has an "identity of interest" with the applicant (*e.g.*, spouse, kinship, stock ownership). *See* 47 C.F.R. §§ 1.2110(b)(4); 21.961(d). Submission of the information listed in *Items (1)-(7)* below will clearly demonstrate compliance with our rules requiring identification of the affiliates of small business applicants.

*Item (1) Name and address:* Identify the name and address of the affiliate of the applicant. If the affiliate is an individual, provide the name and address of that person, and indicate whether the affiliate is a partner, officer, director, or key manager (*e.g.*, CEO, General Manager) of the applicant. If the affiliate is a corporation, provide the name and address of the corporate office and the name and title of an officer, director or authorized contact. If the affiliate is a partnership, provide the name and address of all partners, or the name, title and address of an authorized contact for the partnership.

*Item (2) Relationship to Other Affiliate(s):* Indicate whether the affiliate of the applicant is related to any other affiliate by blood or marriage, and provide the name of the related affiliate.

*Item (3) Citizenship:* Indicate whether the affiliate is a U.S. citizen or U.S. corporation. If the affiliate is a partnership, indicate whether each partner is a U.S. citizen. Applicants should list all foreign partners regardless of whether they are general or limited partners, except that applicants need not list a limited partner: (1) whose level of ownership in the applicant does not exceed the level allowed by Section 310(b); and (2) who is "insulated" from the management and control of the partnership. *See Wilner and Scheiner*, 103 FCC 2d 511 (1985), *recon. granted in part*, 1 FCC Rcd 12 (1986).

*Item (4) Type of Interest Held:* Indicate whether the interest held by the affiliate of the applicant is in the form of stocks, bonds, warrants, partnership, etc. If interests are held in stock, specify the class of stock and any voting rights associated with the stock. If the interests are held in a partnership, indicate whether the interests are limited or general partnership interests.

*Item (5) Amount Held:* Specify the amount held by the affiliate (*e.g.*, number of shares of stock) for each type of interest specified.

*Item (6) Percentage Held:* Specify the percentage held by the affiliate in the applicant based on any combined holdings.

*Item (7) Held on Behalf of:* If an interest is held by the affiliate in trust, or on behalf of another person or entity, identify the party for whom the interest is held.

3. A document setting forth the gross revenues of the applicant and of all individuals and entities identified as affiliates of the applicant in the exhibit described immediately above.<sup>1</sup> The gross revenues of the applicant and its affiliates for the preceding three years, and an average of those numbers, should be stated. Thus, for each applicant and its affiliates, there should be a total of four figures -- gross revenues for years 1-3 and an average of those three figures. The aggregate of the applicant's and affiliates' average gross revenues must be no more than \$40 million for the applicant to establish its status as a small business.

<sup>1</sup> Gross revenues must be evidenced by audited financial statements. *See* 47 C.F.R. § 21.961(c). These audited financial statements must be retained by the bidder and are subject to audits by the Commission. *See* 47 C.F.R. § 21.960(f) & (g). Audited financial statements need not be attached to the FCC Form 304.
