WIRELESS TELECOMMUNICATIONS BUREAU ANNOUNCES JUNE 8, 1998 ELECTION DATE FOR BROADBAND PCS C BLOCK LICENSEES

PAYMENTS FOR C AND F BLOCK LICENSEES RESUME JULY 31, 1998

The Wireless Telecommunications Bureau (Bureau), pursuant to the *Order on Reconsideration of the Second Report and Order* (*Reconsideration Order*),¹ announces that the Election Date for Broadband Personal Communications Services (PCS) is **June 8, 1998**.² Any "new money" necessary for prepayment of licenses under the *Reconsideration Order* must be paid to the Commission on the Election Date.³

Installment payments for broadband PCS C and F block licensees will resume on **July 31, 1998**. On that date, licensees are required to pay accrued interest from April 1, 1998, through and

including July 31, 1998, plus one-eighth of their Suspension Interest.⁴ Payments received after July 31, 1998, but on or before October 29, 1998, must include a late payment fee equal to 5 percent of the amount that was due on July 31, 1998.⁵

The Bureau will announce, in the near future by Public Notices, the specific procedures for filing elections and for remitting funds to the Commission.⁶
