BROADCAST APPLICATIONS DISMISSED FOR FAILURE TO PARTICIPATE IN CLOSED BROADCAST AUCTION

On July 9, 1999, the Mass Media Bureau and Wireless Telecommunications Bureau (Bureaus) issued a *Public Notice*, DA 99-1346 (July 9th *Public Notice*), announcing the filing requirements for the Closed Broadcast Auction scheduled to begin on September 28, 1999 (Auction No. 25). The July 9th *Public Notice* also included a list of those applications for new AM radio, FM radio, full power television, FM Translator, TV Translator and Low Power Television facilities that would be included in the September 28, 1999 auction. Pursuant to the July 9th *Public Notice*, those applicants that did not settle with the other applicants in their mutually exclusive application groups and that intended to participate in the auction were required to submit an FCC Form 175 by 5:30 PM ET on August 20, 1999. *See also* 47 C.F.R. § 73.5002(b) and Implementation of Section 309(j) of the Communications Act – Competitive Bidding for Commercial Broadcast and Instructional Television Fixed Service Licenses, *First Report and Order*, MM Docket No. 97-234, 13 FCC Rcd 15920 (1998). The July 9th *Public Notice* stated that those applicants that did not submit an FCC Form 175 by the August 20, 1999 deadline would have their long form applications (FCC Form 301, 346 or 349) dismissed.

The Commission did not receive an FCC Form 175 for the following long form applications (or a separate request to dismiss the long form application or settlement) and these applications are therefore dismissed:
